The LEGO movie 2: The Second Part
Official Sweepstakes Rules (“Official Rules”)

1) Promotion Description: Chiquita Fresh North America L.L.C. (the “**Sponsor**”) is offering *The LEGO movie 2: The Second Part* (“**LM2**”) sweepstakes (the “**Promotion**”) and will award prizes using a random selection process. The Promotion begins January 15, 2019 at 12:00:01 AM U.S. Eastern Time (“**ET**”) and ends February 24, 2019 at 11:59:59 PM ET (“**Promotion Period**”).

2) Eligibility: The Promotion is an online promotion and only open to those individuals who: (a) are legal residents of the fifty (50) United States, the District of Columbia, (excluding Puerto Rico and all other U.S. territories and possessions and overseas military installations), or Canada (excluding Quebec), (b) are eighteen (18) years of age or older and/or have reached the age of majority in their state, province or territory of residence at time of participation and (c) adhere to all Official Rules. In addition, during the same period, and while supplies last, Chiquita conventional bananas (bunches and single bananas) will feature a game code (“**Game Code**”) in its Stickers (“**Game Sticker**”). Game Stickers are NOT available on Chiquita organic bananas, Chiquita Minis®, Chiquita plantains or Chiquita pineapples.

To receive one (1) entry, visit www.chiquita.com/build (“**Promotional Website**”) and complete the registration form (“**Registration Form**”) with the Game Code, your first/last name, e-mail address, street address, city, state/province, zip/postal code, country, your acceptance of the Terms and Conditions and certification that you are at least 18 years of age. Additionally you must complete the puzzle in order to receive an entry. Entries will only be accepted on the Promotional Website via the completion of the Registration Form. There are twelve (12) different Game Codes available. There is a limit of one (1) Game Code per entry and a limit of three (3) entries per person per day. For the purposes of this Promotion a “day” is defined as any twenty-four hour period during the Promotion Period that begins at 12:00:00 AM ET and ends at 11:59:59 PM ET. There is also a limit of one (1) prize per person for the entire Promotion Period. Entries will only be accepted during the Promotion Period, meaning that the deadline to enter the Promotion is February 24, 2019 at 11:59:59 PM ET.
