By participating in the Promotion, you (the "Entrant") unconditionally accept and agree to comply with and abide by these Official Rules (the "Official Rules") and the decisions of Chiquita Brands L.L.C., Chiquita (Canada) Inc. (collectively, the "Sponsors") and US Sweepstakes & Fulfillment Co. (the "Promotion Administrator"), which shall be final and binding in all respects. Failure to comply with these Official Rules may result in disqualification from the Promotion.

- 1. ELIGIBILITY:** The Promotion is only open to those individuals who: (i) enter the Promotion in accordance with these Official Rules; (ii) are legal residents of the 50 United States, including the District of Columbia, or Canada (excluding Quebec); (iii) are age 18 or older and the age of majority in their state, province or territory of residence (19 and older in Alabama, British Columbia, Nebraska, New Brunswick, Newfoundland, Northwest Territories, Nova Scotia, Nunavut, and Yukon; 21 and older in Mississippi) at the time of entry; and (iv) adhere to these Official Rules and accept the Sponsors' Privacy Policy which can be found at <https://www.chiquita.com/privacy-policy/>.  - c. **Step Three:** Comment on the Chiquita Post with the hashtag #PackLikeTheBest.
 - d. **Step Four:** Once the above steps (a), (b), and (c) are completed, you will receive a series of direct messages from @chiquitabanana (the “**Entry Direct Messages**”). Follow the instructions in the Entry Direct Messages from @chiquitabanana to read, accept, and agree to the Official Rules and the applicable Privacy Policy. You will also be required to provide the following information to complete your entry:
 - First and last name
 - Email address
 - Country of residence

By completing the above steps (a), (b), (c) and (d) in their entirety you will receive one (1) entry into the Promotion (the “**Entry**”). For the avoidance of doubt, commenting on the Chiquita Post alone will NOT result in an entry into the Promotion. Sponsors are not responsible for lost, late, incomplete, illegible, garbled, inaccurate, invalid, misdirected, undelivered, or delayed Entries. No altered or incomplete submissions will be accepted. Standard data rates may apply if a mobile device is used for Entry. Check with your wireless service provider for details. Wireless internet access may

not be available in certain areas and is not available on all mobile devices/wireless service providers.
